Composite Description: The MFS Blended Research - Emerging Markets Equity Composite includes all discretionary portfolios managed to the MFS Blended Research - Emerging Markets Equity strategy that seek to outperform the MSCI Emerging Markets Index over a full market cycle with controlled tracking error. The strategy seeks to provide long-term growth of capital through investment primarily in emerging markets securities selected through a blend of fundamental and quantitative research. Fundamental research focuses on quality and valuation with a long-term investment horizon. Quantitative research, which utilizes multi-factor models, provides an objective appraisal that complements the qualitative perspective of fundamental research. MFS' investment analysis, development and use of quantitative models, and selection of investments may not produce the intended results and/or can lead to an investment focus that results in underperforming portfolios with similar investment strategies and/or the markets in which the portfolio invests. MSCI EMF (Emerging Markets) - Net Return - a market capitalization-weighted index that is designed to measure equity market performance in the global emerging markets.

Composite Dispersion is measured by the asset-weighted standard deviation of gross of fees account returns for all accounts in the composite for the full period. For composites containing less than six accounts for the full period, dispersion is deemed not meaningful and is not presented. The three-year annualized ex post standard deviation measures the variability of the gross of fees composite returns and the benchmark returns over the preceding 36-month period.

Historical performance results may have differed had the composite included assets of client accounts during these time periods for various reasons including the impact of cash flows.

The MFS Blended Research - Emerging Markets Equity composite is a US Dollar based composite available globally. The regional composite depicted here was created on 24-March-2015 for presentation in the European market. Where appropriate, data has been converted to Euro and the fees and breakpoints depicted are applicable to clients in this market.

Prior to 1-Jul-2020, the maximum institutional separate account fee charged for this product was 60 bps.

The composite asset minimum changed from 2MM USD to 1MM USD effective 1-Nov-2022.



Accounts are eligible for inclusion in the composite if they have assets greater than 1 MM USD (1 MM EUR). Accounts are included as of their first full month of performance.
