Composite Description: The MFS Blended Research - Global Equity Composite includes all discretionary portfolios managed to the MFS Blended Research - Global Equity strategy that seek to outperform the MSCI All Country World Index over a full market cycle with controlled tracking error and do not have extensive guideline restrictions. The strategy seeks to provide long-term growth of capital through investment in global equity securities, including emerging markets, selected through a blend of fundamental and quantitative research. Fundamental research focuses on quality and valuation with a longterm investment horizon. Quantitative research, which utilizes multi-factor models, provides an objective appraisal that complements the qualitative perspective of fundamental research. MSCI AC World Index - Net Return - a market capitalization-weighted index that is designed to measure equity market performance in the global developed and emerging markets.

Composite Dispersion is measured by the asset-weighted standard deviation of gross of fees account returns for all accounts in the composite for the full period. For composites containing less than six accounts for the full period, dispersion is deemed not meaningful and is not presented. The three-year annualized ex post standard deviation measures the variability of the gross of fees composite returns and the benchmark returns over the preceding 36-month period.

The MFS Blended Research - Global Equity composite is a U.S. Dollar based composite available globally. The regional composite depicted here was created on 26-Sep-2017 for presentation in the Japanese market. Where appropriate, data has been converted to Japanese Yen and the fees and breakpoints depicted are applicable to clients in this market.

The composite asset minimum changed from 2MM USD to 1MM USD effective 1-Nov-2022.
