Composite Description: The MFS Blended Research - U.S. Mid Cap Equity Composite includes all discretionary portfolios managed to the MFS Blended Research - U.S. Mid Cap Equity strategy that seek to outperform the Russell Midcap- Total Return Index over a full market cycle with controlled tracking error. The strategy seeks to provide long-term growth of capital through investment in equity securities, generally of U.S. mid-capitalization companies, selected through a blend of fundamental and quantitative research.

Fundamental research focuses on quality and valuation with a long-term investment horizon. Quantitative research, which utilizes a multi-factor model, provides an objective appraisal that complements the qualitative perspective of fundamental research. Russell Midcap® - Total Return - is a market capitalization weighted index representing the smallest 800 companies in the Russell 1000 Index constructed to provide a comprehensive barometer for securities in the mid-cap segment of the U.S. equity universe.

Composite Dispersion is measured by the asset-weighted standard deviation of gross of fees account returns for all accounts in the composite for the full period. For composites containing less than six accounts for the full period, dispersion is deemed not meaningful and is not presented. The three-year annualized ex post standard deviation measures the variability of the gross of fees composite returns and the benchmark returns over the preceding 36-month period.

Historical performance results may have differed had the composite included assets of client accounts during these time periods for various reasons including the impact of cash flows.

The MFS Blended Research - U.S. Mid Cap Equity Composite is a US Dollar based composite available globally. The regional composite depicted here was created on 1-March-2016 for presentation in the European market. Where appropriate, data has been converted to Euro and the fees and breakpoints depicted are applicable to clients in this market.

Prior to 1-Jul-2020, the maximum institutional separate account fee charged for this product was 45 bps.

The composite asset minimum changed from 2MM USD to 1MM USD effective 1-Nov-2022.
