Composite Description: The MFS Global Equity Composite includes all discretionary portfolios managed to the MFS Global Equity strategy that have unhedged currency exposure and do not have country-specific restrictions. The strategy seeks long-term growth of capital through investments in a diversified portfolio of global companies with durable above-average growth and return prospects and reasonable valuation. Investments in certain markets can involve greater risk and volatility because of adverse market, currency. economic, industry, political, regulatory, geopolitical, or other conditions. Derivative Exposure Disclosure

Certain accounts in this composite utilize derivatives for hedging, investment exposure, implementation efficiency, and transaction cost mitigation purposes. Derivative exposures can be volatile, used to take long or short positions, involve leverage (which can magnify gains or losses), and involve counterparty and liquidity risk. The table below displays the high, median, and low month-end derivative exposures over the last three years, when available or since inception if the composite is less than three years old. The composite asset minimum changed from 2MM USD to 1MM USD effective 1-Nov-2022.
