Composite Description: The MFS Global Growth Concentrated Equity Composite includes all discretionary portfolios managed to the MFS Global Growth Concentrated Equity strategy. The strategy seeks long-term capital appreciation by investing principally in a concentrated portfolio of 20-30 stocks of companies worldwide that have the potential to generate higher earnings growth and returns over the long term than their industry, and whose stock valuations do not fully reflect their long-term growth prospects. Investments in certain markets can involve greater risk and volatility because of adverse market, currency, economic, industry, political, regulatory, geopolitical, or other conditions. Stock markets and investments in individual stocks are volatile and can decline significantly in response to or investor perception of, issuer, market, economic, industry, political, regulatory, geopolitical, and other conditions. MSCI AC World Index - Net Return - a market capitalization-weighted index that is designed to measure equity market performance in the global developed and emerging markets.

Composite Dispersion is measured by the asset-weighted standard deviation of gross of fees account returns for all accounts in the composite for the full period. For composites containing less than six accounts for the full period, dispersion is deemed not meaningful and is not presented. The three-year annualized ex post standard deviation measures the variability of the gross of fees composite returns and the benchmark returns over the preceding 36-month period.

The MFS Global Growth Concentrated Equity Composite is a US Dollar based composite available globally. The regional composite depicted here was created on 25-November-2020 for presentation in the Australian market. Where appropriate, data has been converted to Australian Dollar and the fees and breakpoints depicted are applicable to clients in this market.

Historical performance results may have differed had the composite included assets of client accounts during these time periods for various reasons including the impact of cash flows.

The composite asset minimum changed from 2MM USD to 1MM USD effective 1-Nov-2022.

Prior to 1-Sep-2023, the maximum institutional separate account fee charged for this product was 80 bps.
