**Composite Description:** The MFS International Equity Composite includes all discretionary portfolios managed to the MFS International Equity strategy that do not have extensive guideline restrictions. The strategy seeks capital appreciation by investing principally in a diversified portfolio of equities of companies whose primary activities lie outside of the United States. Portfolios in this strategy seek companies that provide above-average, durable earnings growth and whose stocks trade at a discount to their expected growth rate. Not all portfolios will have exposure to emerging market securities. Investments in certain markets can involve greater risk and volatility because of adverse market, currency, economic, industry, political, regulatory, geopolitical, or other conditions. MSCI EAFE - Net Return - a market capitalization-weighted index that is designed to measure equity market performance in the developed markets, excluding the U.S. and Canada.

Composite Dispersion is measured by the asset-weighted standard deviation of gross of fees account returns for all accounts in the composite for the full period. For composites containing less than six accounts for the full period, dispersion is deemed not meaningful and is not presented. The three-year annualized ex post standard deviation measures the variability of the gross of fees composite returns and the benchmark returns over the preceding 36-month period.

The MFS International Equity composite is a US Dollar based composite available globally. The regional composite depicted here was created on 24-Oct-2007 for presentation in the British market. Where appropriate, data has been converted to British Pound and the fees and breakpoints depicted are applicable to clients in this market.

The composite asset minimum changed from 2MM USD to 1MM USD effective 1-Nov-2022.
