Composite Description: The MFS Emerging Markets Debt Diversified Composite includes all discretionary portfolios managed to the MFS Emerging Markets Debt Diversified strategy that seek to outperform the JPMorgan EMBI Global Diversified Index. The strategy focuses on hard currency sovereign debt issued by emerging market countries and may opportunistically invest in hard currency corporate debt issued by companies located in emerging market countries as well as local currency sovereign rates and currencies. Investment decisions are made through a research-intensive process integrating a top-down assessment of global risk with bottom-up country selection. Emerging markets can have less market oversight and greater political, social, geopolitical and economic instability than developed markets. Investments in debt instruments may decline in value as the result of, or perception of, declines in the credit quality of the issuer, borrower, counterparty, or other entity responsible for payment, underlying collateral, or changes in economic, political, issuer-specific, or other conditions. Certain types of debt instruments can be more sensitive to these factors and therefore more volatile. In addition, debt instruments entail interest rate risk (as interest rates rise, prices usually fall).

JP Morgan EMBI Global Diversified - tracks the total returns of USD-denominated debt instruments issued by emerging markets, sovereign and quasi-sovereign entities: Brady bonds, loans, and Eurobonds. The index, which is a uniquely-weighted version of the EMBI Global Index, limits the weights of those index countries with larger debt stocks by only including specified portions of these countries' eligible current face amounts of debt outstanding. Composite Dispersion is measured by the asset-weighted standard deviation of gross of fees account returns for all accounts in the composite for the full period. For composites containing less than six accounts for the full period, dispersion is deemed not meaningful and is not presented. The three-year annualized ex post standard deviation measures the variability of the gross of fees composite returns and the benchmark returns over the preceding 36-month period.

The MFS Emerging Markets Debt Diversified Composite is a US Dollar based composite available globally. The regional composite depicted here was created on 23-May-2019 for presentation in the Australian market. Where appropriate, data has been converted to Australian Dollar and the fees and breakpoints depicted are applicable to clients in this market.

Prior to 1-Jul-2020, the maximum institutional separate account fee charged for this product was 55 bps.
