Composite Description: The MFS Global Aggregate Core Composite includes all discretionary portfolios managed to the MFS Global Aggregate Core strategy that seek to outperform the Bloomberg Global Aggregate Index (Unhedged) over a full market cycle. The strategy invests primarily in investment grade global fixed income asset classes. The index also includes Eurodollar and Euro-Yen corporate bonds, Canadian government, agency and corporate securities, and USD investment grade 144A securities. Composite Dispersion is measured by the asset-weighted standard deviation of gross of fees account returns for all accounts in the composite for the full period. For composites containing less than six accounts for the full period, dispersion is deemed not meaningful and is not presented.
