**Composite Description:** The MFS Fund of Funds - LifePlan 2035 Composite includes all discretionary portfolios managed to the MFS Fund of Funds - LifePlan 2035 strategy. The strategy provides convenient access to a professionally allocated, broadly diversified, rebalanced portfolio of MFS funds in a single investment. The strategy is designed to provide diversification among different asset classes by investing primarily in mutual funds advised by MFS and seeks a high level of total return consistent with its asset allocation until the approximate retirement year in the strategy name; thereafter, the strategy will seek total return through a combination of current income and capital appreciation with a designated allocation to equities and fixed income. The asset allocation of the strategy will change over time and will become more conservative as the target date approaches. MFS' strategy of investing in underlying portfolios expose the portfolio to the risks of the underlying portfolios. Each underlying portfolio pursues its own objective and strategies and may not achieve its objective. In addition, shareholders of the portfolio will indirectly bear the fees and expenses of the underlying portfolios. Custom Benchmark: S&P/TSX Capped Composite Index - Comprises the majority of market capitalization for Canadian-based, Toronto Stock Exchange listed companies with the relative weight by market capitalization of any single index constituent is capped at 10%. FTSE Canada Universe Bond - a market capitalization index designed as a broad measure of the Canadian investment-grade fixed income market. FTSE EPRA/NAREIT Developed Total Return - measures the performance of eligible real estate equities worldwide that generate a majority of their revenue and income through the ownership, disposal and development of income-producing real estate. MSCI World Index-Net Return - a market capitalization-weighted index that is designed to measure equity market performance in the global developed markets.

Custom Benchmark Methodology: As of 31-Dec-2024, the custom benchmark blend consisted of 5.3% FTSE EPRA/NAREIT Developed Total Return, 45.3% MSCI World Index - Net Return, 12.7% S&P/TSX Capped Composite Index and 36.7% FTSE Canada Universe Bond. Rebalanced monthly. The historical components and weightings of the custom benchmark are available upon request.

Composite Dispersion is measured by the asset-weighted standard deviation of gross of fees account returns for all accounts in the composite for the full period. For composites containing less than six accounts for the full period, dispersion is deemed not meaningful and is not presented. The three-year annualized ex post standard deviation measures the variability of the gross of fees composite returns and the benchmark returns over the preceding 36-month period.

Prior to 1-Feb-2018, the maximum institutional separate account fee charged for this product was 75 bps. From 1-Feb-2018 through 31-Aug-2020, the maximum institutional separate account fee charged for this product was 50 bps.

On 23-Aug-2022, the custom benchmark blend was change from 5% FTSE Canada 91 Day T-Bill, 25% FTSE Canada Universe Bond, 35% MSCI AC World and 35% S&P/TSX Capped Composite Index to as of 31-Dec-2021: 6.5% FTSE EPRA/NAREIT Developed Total Return, 52.7% MSCI World Index - Net Return, 15.1% S&P/TSX Capped Composite Index and 25.7% FTSE Canada Universe Bond. The change is retroactive from inception of the composite.



The composite asset minimum changed from 5MM USD to 1MM USD effective 1-Nov-2022.
