Composite Description: The MFS Lifetime 2055 Composite includes all discretionary portfolios managed to the MFS Lifetime 2055 strategy. The strategy provides convenient access to a professionally allocated, broadly diversified, rebalanced portfolio of MFS portfolios in a single investment. The strategy is designed to provide diversification among different asset classes by investing primarily in portfolios advised by MFS and seeks a high level of total return consistent with its asset allocation until the approximate retirement vear in the strategy name: thereafter, the strategy will seek total return through a combination of current income and capital appreciation with a designated allocation to equities and fixed income. The asset allocation of the strategy will change over time and will become more conservative as the target date approaches. MFS' strategy of investing in underlying portfolio exposes the portfolio to the risks of the underlying portfolio. Each underlying portfolio pursues its own objective and strategies and may not achieve its objective. Custom Benchmark: Bloomberg U.S. Aggregate Bond Index - a market capitalization-weighted index that measures the performance of the U.S. investment-grade, fixed rate bond market, with index components for government and corporate securities, mortgage pass-through securities, and asset-backed securities with at least one year to final maturity. Bloomberg Commodity Index - designed to be a highly liquid and diversified benchmark for the commodity futures market. Custom Benchmark Methodology: As of 31-Dec-2024, the custom benchmark blend consisted of 5% Bloomberg U.S. Aggregate Bond Index, 5% Bloomberg Commodity Index, 5% FTSE EPRA/NAREIT Developed Net Return, 28% MSCI EAFE Index (net div) and 57% S&P 500 Index. Rebalanced monthly. The historical components and weightings of the custom benchmark are available upon request.

Composite Dispersion is measured by the asset-weighted standard deviation of gross of fees account returns for all accounts in the composite for the full period. For composites containing less than six accounts for the full period, dispersion is deemed not meaningful and is not presented. The three-year annualized ex post standard deviation measures the variability of the gross of fees composite returns and the benchmark returns over the preceding 36-month period.

Effective 1-Jan-2023, the composite was re-activated after being terminated as of December 2019.

Effective 1-Dec-2022, the composite name changed from MFS Fund of Funds - Lifetime 2055 Composite to MFS Lifetime 2055 Composite.

The composite asset minimum changed from 5MM USD to 1MM USD effective 1-Nov-2022.
