Composite Description: The MFS Global G Equity ex-Japan Composite includes all discretion portfolios managed to the MFS Global Growth E strategy that restrict investing in securities issue companies in Japan. The strategy seeks long-ter capital appreciation by investing principally in a diversified portfolio of stocks of companies in deand emerging economies (excluding Japan) that the potential to generate higher earnings growth returns over the long term than their industry, and whose stock valuations do not fully reflect their longterm growth prospects. Investments in certain markets can involve greater risk and volatility because of adverse market, currency, economic, industry, political, regulatory, geopolitical, or other conditions. MSCI AC World Index ex Japan - Net Return - a market capitalization-weighted index that is designed to measure equity market performance in the global developed and emerging markets excluding Japan.

Composite Dispersion is measured by the asset-weighted standard deviation of gross of fees account returns for all accounts in the composite for the full period. For composites containing less than six accounts for the full period, dispersion is deemed not meaningful and is not presented. The three-year annualized ex post standard deviation measures the variability of the gross of fees composite returns and the benchmark returns over the preceding 36-month period.

The composite asset minimum changed from 3MM USD to 1MM USD effective 1-Nov-2022.

On 20-May-2024: the benchmark was changed from MSCI AC World Index ex Japan Growth - Net Return to MSCI AC World Index ex Japan - Net Return. The change is retroactive from inception of the composite.
