Composite Description: The MFS International Small-Mid Cap Concentrated Equity Composite includes all discretionary portfolios managed to the MFS International Small-Mid Cap Concentrated Equity strategy. The strategy seeks capital appreciation by investing primarily in a concentrated portfolio of equities of small-to-medium-capitalization companies whose primary activities lie outside the United States. The portfolio's performance could be more volatile than the performance of more diversified portfolios. MSCI AC World Index ex USA Small Mid - Net Return - is a free float weighted index that is designed to measure equity market performance of small and mid cap companies across global developed and emerging market countries, excluding the United States.

Composite Dispersion is measured by the asset-weighted standard deviation of gross of fees account returns for all accounts in the composite for the full period. For composites containing less than six accounts for the full period, dispersion is deemed not meaningful and is not presented. The three-year annualized ex post standard deviation measures the variability of the gross of fees composite returns and the benchmark returns over the preceding 36-month period.

The composite asset minimum changed from 2MM USD to 1MM USD effective 1-Nov-2022.

For purposes of GIPS compliance, the firm is defined as MFS Investment Management (MFS), which is comprised of Massachusetts Financial Services Company and MFS Institutional Advisors, Inc.
