Composite Description: The MFS Japan Equity Composite includes all discretionary portfolios managed to the MFS Japan Equity strategy that do not have extensive guideline restrictions. The strategy seeks capital appreciation by investing in a diversified portfolio of Japanese companies that the Japan equity analyst team believe are high-quality, durable businesses trading at attractive valuations. TOPIX Gross Return - is a capitalization weighted gross return index of all companies listed on the First Section of the Tokyo Stock Exchange.

Composite Dispersion is measured by the asset-weighted standard deviation of gross of fees account returns for all accounts in the composite for the full period. For composites containing less than six accounts for the full period, dispersion is deemed not meaningful and is not presented. The three-year annualized ex post standard deviation measures the variability of the gross of fees composite returns and the benchmark returns over the preceding 36-month period.

From 1-April-2010 to 31-May-2014, the maximum institutional separate account fee charged for this product was 70 bps.

The composite asset minimum changed from 2MM USD to 1MM USD effective 1-Nov-2022.
