Composite Description: The MFS Low Volatility Global Equity Developed Market Composite includes all discretionary portfolios managed to the MFS Low Volatility Global Equity Developed Market strategy that seek to outperform the MSCI World Index, with lower volatility, over a full market cycle through investments in global securities selected through a blend of fundamental and quantitative research. Fundamental research focuses on quality and valuation with a longterm investment horizon. Quantitative research, which utilizes multi-factor models, provides an objective appraisal that complements the qualitative perspective of fundamental research. Composite Dispersion is measured by the asset-weighted standard deviation of gross of fees account returns for all accounts in the composite for the full period. For composites containing less than six accounts for the full period, dispersion is deemed not meaningful and is not presented. The three-year annualized ex post standard deviation measures the variability of the gross of fees composite returns and the benchmark returns over the preceding 36-month period.

The composite asset minimum changed from 2MM USD to 1MM USD effective 1-Nov-2022.
