**Composite Description:** The MFS Blended Research - U.S. Core Equity Composite includes all discretionary portfolios managed to the MFS Blended Research - U.S. Core Equity strategy that seek to outperform the S&P 500 Index over a full market cycle with controlled tracking error and that do not have extensive guideline restrictions. The strategy seeks to provide long-term growth of capital through investment in equity securities, generally of U.S. companies, selected through a blend of fundamental and quantitative research. Fundamental research focuses on quality and valuation with a long-term investment horizon. Quantitative research, which utilizes a multi-factor model, provides an objective appraisal that complements the qualitative perspective of fundamental research. MFS' investment analysis, development and use of quantitative models, and selection of investments may not produce the intended results and/or can lead to an investment focus that results in underperforming portfolios with similar investment strategies and/or the markets in which the portfolio invests. Composite Dispersion is measured by the asset-weighted standard deviation of gross of fees account returns for all accounts in the composite for the full period. For composites containing less than six accounts for the full period, dispersion is deemed not meaningful and is not presented. The three-year annualized ex post standard deviation measures the variability of the gross of fees composite returns and the benchmark returns over the preceding 36-month period.
