Composite Description: The MFS U.S. Taxable Municipal Fixed Income 1-18 Year Composite includes all discretionary portfolios managed in the MFS U.S. Taxable Municipal Fixed Income (1-18 Year) strategy. The strategy seeks to outperform the Bloomberg Municipal Taxable Bonds 1-18 Year Index over full market cycles through investments primarily in investment grade rated U.S. taxable municipal debt securities. Investments in municipal instruments can be volatile and significantly affected by adverse tax or court rulings, legislative or political changes, market and economic conditions, issuer, industry-specific (including the credit quality of municipal insurers), and other conditions. Because many municipal instruments are issued to finance similar projects, conditions in certain industries can significantly affect the portfolio and the overall municipal market.

Bloomberg Municipal Index Taxable Bonds 1-18 Year - is a market capitalization-weighted index that measures the performance of the intermediate-term (1 to 18 years) tax-exempt bond market.

Composite Dispersion is measured by the asset-weighted standard deviation of gross of fees account returns for all accounts in the composite for the full period. For composites containing less than six accounts for the full period, dispersion is deemed not meaningful and is not presented. The three-year annualized ex post standard deviation measures the variability of the gross of fees composite returns and the benchmark returns over the preceding 36-month period.
