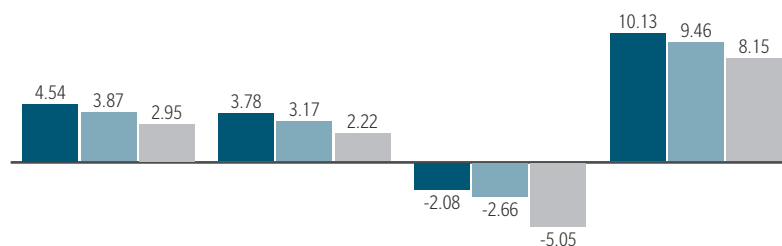

Composite Description: The MFS Blended Research - Emerging Markets Equity Composite includes all discretionary portfolios managed to the MFS Blended Research - Emerging Markets Equity strategy that seek to outperform the MSCI Emerging Markets Index over a full market cycle with controlled tracking error. The strategy seeks to provide long-term growth of capital through investment primarily in emerging markets securities selected through a blend of fundamental and quantitative research. Fundamental research focuses on quality and valuation with a long-term investment horizon. Quantitative research, which utilizes multi-factor models, provides an objective appraisal that complements the qualitative perspective of fundamental research.
