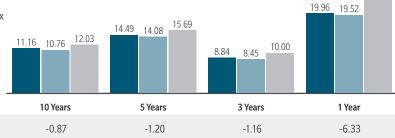

The three-year annualized ex post standard deviation measures the variability of the gross-of-fees composite returns and the benchmark returns over the preceding 36-month period. The composite asset minimum changed from 2MM USD to 1MM USD on 01-Nov-2022.
