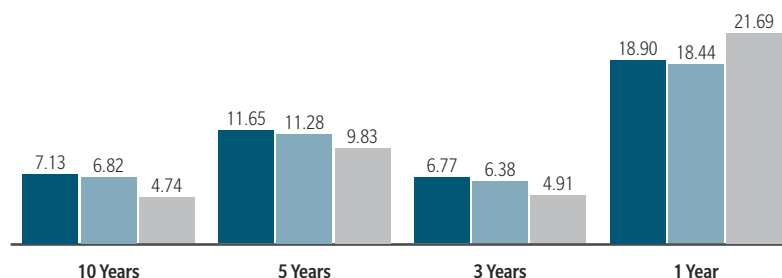
Philosophy

Composite Description: The MFS European Equity ex-U.K. Composite includes all discretionary portfolios managed to the MFS European Equity strategy that restrict investing in securities issued by companies in the United Kingdom. The strategy seeks capital appreciation by investing primarily in a portfolio of European equity securities, excluding the United Kingdom, that MFS believes have attractive valuations and above-average growth prospects. Because the portfolio may invest a substantial amount of its assets in issuers located in a single country or in a limited number of countries, it may be more volatile than a portfolio that is more geographically diversified. Accounts are eligible for inclusion in the composite if they have assets greater than 1 MM USD. Accounts are included as of their first full month of performance.

Derivative Exposure Disclosure

Certain accounts in this composite utilize derivatives for hedging, investment exposure, implementation efficiency, and transaction cost mitigation purposes. Composite Dispersion is measured by the asset-weighted standard deviation of gross-of-fees account returns for all accounts in the composite for the full period. For composites containing less than six accounts for the full period, dispersion is deemed not meaningful and is not presented. The three-year annualized ex post standard deviation measures the variability of the gross-of-fees composite returns and the benchmark returns over the preceding 36-month period.

The MFS European Equity ex U.K. composite is a British Pound based composite available globally. The regional composite depicted here was created on 29-Jun-2011 for presentation in the US market.
