Philosophy

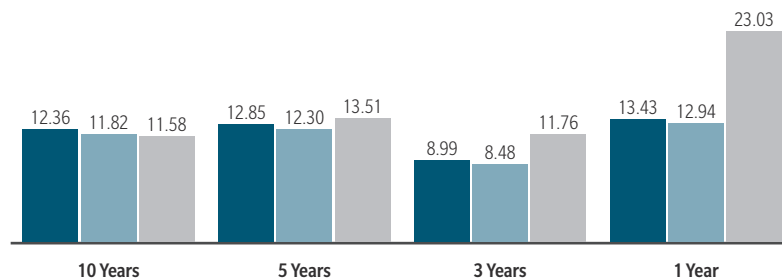
We believe:
