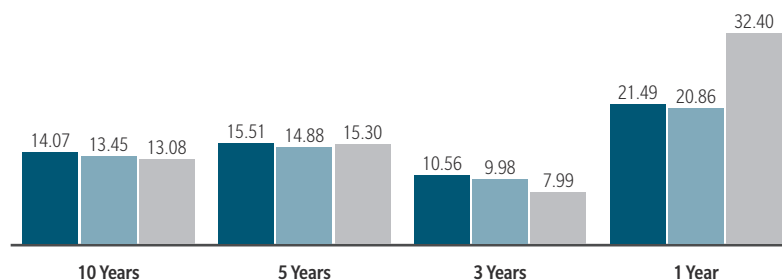
The tenets of our investment philosophy are based upon the following beliefs:
