## Philosophy

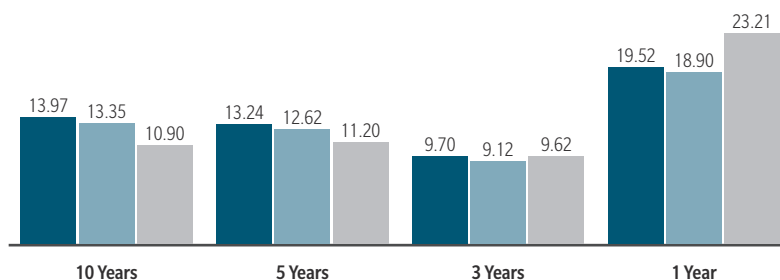
The tenets of our investment philosophy are based upon the following beliefs:

Composite Dispersion is measured by the asset-weighted standard deviation of gross of fees account returns for all accounts in the composite for the full period. For composites containing less than six accounts for the full period, dispersion is deemed not meaningful and is not presented. The three-year annualized ex post standard deviation measures the variability of the gross of fees composite returns and the benchmark returns over the preceding 36-month period.

The MFS Global Growth Equity composite is a US Dollar based composite available globally. The regional composite depicted here was created on 27-Jun-2011 for presentation in the Canadian market. Where appropriate, data has been converted to Canadian Dollar and the fees and breakpoints depicted are applicable to clients in this market.

Prior to 1-Jul-2020, the maximum institutional separate account fee charged for this product was 75 bps.

The composite asset minimum changed from 2MM USD to 1MM USD effective 1-Nov-2022.

On 19-Dec-2023: the benchmark was changed from MSCI AC World Index Growth - Net Return to MSCI AC World Index - Net Return. The change is retroactive from inception of the composite.
