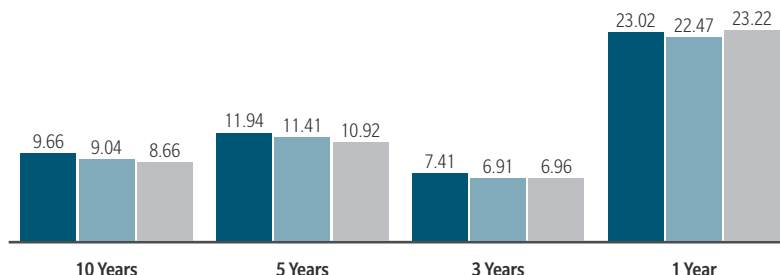
Philosophy
