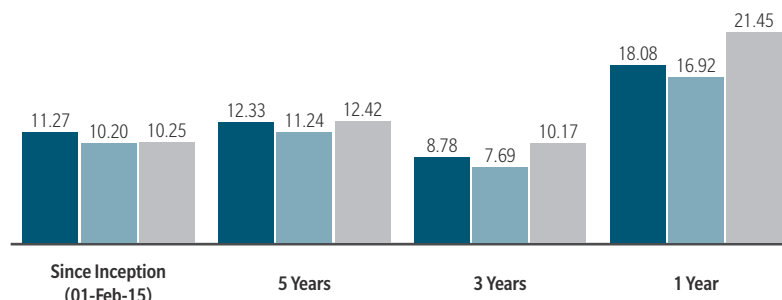
Philosophy
