Philosophy

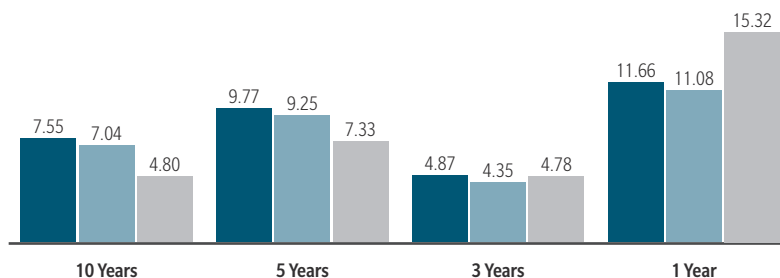
The strategy seeks to generate returns by:

- Investing with a long-term investment horizon, which capitalizes on opportunities created by investors with shorter investment horizons. Our global research platform, collaborative investment approach and compensation structure are all aligned with this timeframe.
- Seeking companies we believe have above-average, durable growth and return prospects over the long term. Typically these companies have identifiable competitive advantages that lead to fairly predictable earnings and cash flow, strong balance sheets, management interests that are aligned with shareholders, and transparent corporate governance.
- Managing capital with the goal of attempting to avoid stocks with substantial downside risk, and only invest where we believe valuations more than compensate for inherent risks. Downside risk is emphasized in stock selection, portfolio construction, and risk management.

Composite Description: The MFS International Concentrated Equity Composite includes all discretionary portfolios managed to the MFS International Concentrated Equity strategy that do not have extensive guideline restrictions. The strategy seeks capital appreciation by investing principally in a concentrated portfolio of equities of companies whose primary activities lie outside of the United States. Portfolios in this strategy seek companies that provide above-average, durable earnings growth and whose stocks trade at a discount to their expected growth rate. Portfolios in this strategy are typically concentrated in 25-35 stocks. The portfolio's performance could be more volatile than the performance of more diversified portfolios. Composite Dispersion is measured by the asset-weighted standard deviation of gross of fees account returns for all accounts in the composite for the full period. For composites containing less than six accounts for the full period, dispersion is deemed not meaningful and is not presented. The three-year annualized ex post standard deviation measures the variability of the gross of fees composite returns and the benchmark returns over the preceding 36-month period.
